

# **APPOINTMENT FEE**

A fee of \$ 12.50 will be charged on freight being delivered to consignees who require appointment deliveries.

#### **BILL OF LADING**

A fee of \$ 2.00 per copy of a bill of lading will be charged. This applies to bills of lading attached to invoices, unless an extra copy is supplied at the time of shipment.

# **CLAIMS**

Ant claim of \$ 50.00 or less will not be processed.

# C.O.D. FEE

On deliveries where a cheque is to be picked up for the value of the goods being delivered, before release of such goods, a 5 % fee on the value of the goods with a minimum of \$ 25.00 will be charged.

# **DANGEROUS GOODS**

On shipments moving under the regulations for the Transportation of Dangerous Goods, a charge of \$ 10.00 per bill of lading will be assessed.

#### **DEMURRAGE**

On deliveries requiring dropped trailers for unloading, a demurrage allowance of one (1) day will be allowed. Days incurred in excess of the one-day allowance will incur a fee of \$ 45.00 per day. This will be billed monthly.

# **EXHIBITIONS OR FAIRS**

Pick up and delivery will be performed at trade shows, conventions, fairs, etc.. Such shipments will be subject to \$ 4.50 per cwt on the actual weight with a minimum charge of \$ 75.00 per shipment

# **LATE PAYMENT FEE**

Calculated daily at 1 1/2 %, commencing thirty (30) days from date of invoice.

#### **POWER TAILGATE CHARGE**

Shipments requiring the use of a power tailgate to perform the delivery will be subject to a surcharge of \$ 35.00.

#### **PROOF OF DELIVERY CHARGES**

Copy of P.O.D. - \$ 7.50 per receipt. Fax copy of P.O.D. -(Long Distance) \$ 12.50/receipt.

# RE-DELIVERY/RE-ROUTES/WRONG ADDRESS CHARGES

Shipments that are refused by the consignee and must be re-delivered will be subject to a charge based upon the following cwt rate scale.

#### **RESIDENTIAL & NON-COMMERCIAL**

Shipments that require special handling, due to location and receiving facilities, are subject to an additional charge of \$25.00 per floor.

#### **SECOND FLOOR DELIVERIES**

Our rates are prepared on the basis of dock-to-dock deliveries. Shipments requiring delivery to consignees in multiple floor locations will incur an additional charge of \$25.00 per floor.

# STORAGE CHARGES

Shipments held in our facilities at the request of the shipper will but subject to a storage charge of 7.50 \$ per skid, per day. A 3 day grace period will be allowed at destination terminal prior to charges being assessed

# WHOLESALER CONSIGNEE SURCHARGE-APPOINTMENT/WAIT

Wholesale consignees that require the product to go sorted, re-boarded or cause excessive unloading times will be subject to a surcharge fee. The fee will be calculated as \$1.00 per cwt, minimum &15.00, maximum \$75.00 per shipment.
